NOTIFICATION OF IMPLANT OF A MICROCHIP/TRANSPONDER

The SPSS **MUST** be notified if a microchip/transponder is inserted into a SPSS passported pony/horse at any time after a passport is issued.

If the owner at time of implant is the owner formally recorded in the passport and the vet has added the microchip sticker to the appropriate place in the passport (see notes over) there is no charge for this update and the passport does not have to be returned to the SPSS. However, if there is no microchip sticker in the passport, please return the passport with this form and send £5 to cover return postage (by RM Signed For service).

If the owner at time of implant is **NOT** the owner formally recorded in the passport, then the passport and a completed SPSS transfer of Ownership form and fee **MUST** be returned to the SPSS Studbook Office ASAP

For passports issued before 2016 ownership is recorded in Section III; for passports issued from Jan 2016 it is recorded Section IV (page 16 onwards). Only ownership details that have been embossed with the SPSS seal or stamped with the SPSS stamp are valid.

The SPSS can also record the addition of a microchip for Scottish Sport Horse (SSH) issued passports if they relate to ponies on or under 148cm and for non-UK EU passports (eg a German or Dutch ones) for ponies (or small horses up to 158cm) that are eligible for SPSS over stamping (see page 2). If an SSH / non-UK EU passport has not already been SPSS over stamped then the passport **MUST** be sent to the SPSS along with this form and there is a charge for this (see page 2)

Microchip Sicker

Passports from 2015 or earlier - In passports issued prior to 1st January 2016, the microchip sticker should be added to an appropriate place on the ID diagram (page 2) and the vet should annotate the page with name, signature and practice stamp. If a microchip has been found and there is no sticker in the passport, please return it along with this form and £5 to cover return postage (by RM Signed For service).

Passports from 2016 onwards - If the passport was issued on/after 1st January 2016, there will have been a microchip implanted prior to passport issue and any additional microchip should be recorded in Section I Part C as it is an amendment/ modification to the equine's identification.

Passports issued by organisations other than the SPSS

The SPSS can also update microchip details and record changes of ownership for:

- Scottish Sport Horse (SSH) issued passports if (and only if) they relate to ponies on or under 148cm. SSH horse passports are now maintained by SHB(GB) and more information can be found on their website.
- Non-UK EU passports (eg an Irish, German or Dutch one) for any pony (or small horse up to 158cm) that is eligible for SPSS overamping apart from any pure-bred ponies that have a UK-based studbook (eg Welsh Sec A, B, C, D, Connemara or Caspian). Examples of pony breeds that we will overstamp for the purpose of recording a microchip and/or change of ownership etc include Deutsches Reitponies (DRP), NWPCS Sec K, NRPS, Danish Sports Ponies, part-bred Connemaras and similar. The SPSS then notifies the passport issuer of the changes. Note that this overamping does not put a graded pony into the appropriate SPSS Studbook – please contact us if that is required as well as the change of ownership.

As part of the update process, the SPSS will add the pony's information (including ownership details) to the DEFRA Central Equine Database.

If an eligible pony (or small horse) has not already been overamped by the SPSS, then the fees are:

Members: £25 for one pony; £20 per pony for 2-5 ponies and £15 per pony for 6-10+ ponies

Non members: £40 per pony.

Note that the above fees also include updating the ownership if necessary. If ownership is to be updated then an SPSS Transfer of Ownership Form should be completed as fully as possible and sent with this form and the passport as well as copies of any relevant paperwork (sales receipt etc).
